1. What is personal data?

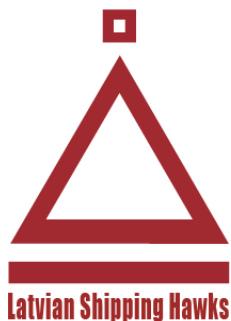
2. The collection, storage and protection of personal data

Every access to our website and every retrieval of a file stored on the website is logged. The following data is logged: The file name, date and time of retrieval, transferred data volume, notification of successful retrieval, web browser and requesting domain. In addition, the IP addresses of the requesting computer are logged. Personal data is only collected if this information is provided voluntarily, e.g. to conclude a contract. Further personal data is only collected if you provide this information voluntarily, for example in the context of an inquiry or for the conclusion or fulfilment of a contract. For the transmission and storage of personal data, the latest generation of encryption methods and access control systems are used to protect them as best as possible from unauthorized access.

3. How is personal data used and passed on?

If you have provided us with personal data, we will only use it to answer your enquiries, to process contracts concluded with you and for technical administration. Your personal data will only be passed on to third parties if this is necessary for the purpose of contract processing or if you have given your prior consent.

4. Right to information, correction and deletion of data

5. What are cookies?

Furthermore, cookies are occasionally used by third parties for the optimized control of our brand and model application. The data obtained in this way is stored in anonymized form only. You can prevent the installation of cookies by setting your browser accordingly. However, we would like to point out that in this case you may not be able to use all functions of this website to their full extent. By using this website, you consent to the processing of data about you by Google.
